WHEN ASAP NATIONAL MISSIONARIES MAKE HOME VISITS, THEY CONDUCT A NEEDS ASSESSMENT AND FOLLOW UP WITH A NECESSARY PLAN TO MEET TANGIBLE NEEDS.
