Humanitarian

ASAP Ministries brought humanitarian relief to the suffering in Cambodia, Laos, Thailand, Vietnam, and Myanmar. Disaster assistance went to provide emergency food supplies and resources to reestablish victim's lives. When ASAP Ethnic missionaries make home visits, they conduct a needs assessment and follow up with a necessary plan to meet tangible needs. Villages with no access to clean drinking water or toilets receive clean water and sanitation facilities. Small enterprise development, projects such as cows and tractors for villagers, small loans, and vocational training increased the quality of life.

Education Projects

ASAP Ministries had the privilege of offering quality Christian education to at-risk children who would otherwise not be able to afford attending school in Southeast Asia and Lebanon. ASAP Ministries supported the operation of over eighty schools and literacy centers. Tuition assistance was provided to promising needy Southeast Asian students who sought higher education. A Keep Kids Safe curriculum was established and implemented in the schools.
